Union membership fees 2017 up to and including 2019

As of January 2017, and following the decision of the SUEPO Congress from 12.05.2017 all SUEPO sites will increase their membership fees by 0.2%. For Munich the membership fees for active staff will therefore be 2.6% of a monthly net salary of the first step of each grade. For retired members, the fee has been increased from 20€ to 30€.

This increase in fee contribution was decided in view of:

- the high legal costs SUEPO incurred in 2015 and 2016,
- the new costs of running SUEPO outside the EPO premises and
- the necessity of topping up the AID fond for supporting those SUEPO committee members dismissed or downgraded in the future.

The new contributions correspond therefore to:
